Will install new entry boot for new line with 3" and hydrostatic test existing fiberglass sump as well as new Overspill Manhole

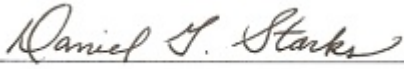
NOTE: Remote fills over 20' in length shall have interstitial monitoring and an audible and visible overfill alarm per 175.445 f)
