Permit for ABANDONMENT IN PLACE of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to abandon in place underground storage tank(s) or piping is hereby granted. Such abandonment must be in complete accordance with acceptable materials as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175, and 176.
