(5) SPECIAL CONTINGENCIES :

The Diesel tank will be abandoned under a seperate abandonment permit. The UL tank #4 will be converted to diesel. We will cap the existing UL product line to tank 4 at the STP sump. A new product line will be installed from the tank 4 STP sump to the existing diesel line in the existing diesel STP sump. The existing line leak detection and tank probes will remain. We will need to change the tank probe floats to diesel in tank #4. The Diesel tank has been pumped out and a change of tank status notification form was sent in.

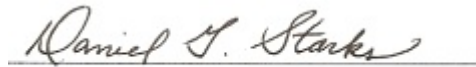
NOTE: Contractor states that the small section of piping that is being installed is less than 20'
