This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

- (5) **SPECIAL CONTINGENCIES** : Discontinue use of tank. Tank and piping to be removed.
