Such installations, upgrades, or repairs must be in complete accordance with acceptable materials and procedures as specified in the Federal Register, Part II Environmental Protection Agency, 40 CFR Parts 280 and 281, and also with all sections of 41 Illinois Administrative Code, Parts 174, 175 and 176. A required job schedule for cathodic protection upgrade of underground storage tank(s) and piping must be submitted to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(5) SPECIAL CONTINGENCIES :

Water table is very high and the probe risers and tank manway lids are always under water and are screwed into tank access man-way. I will add a bag anode on the riser and to the metal manway lid and test.

NOTE: From N.O.V. - Tank access manway sumps are full of water exposing the tank access manway lids to corrosion. Corrosion protection must be installed to protect the metal tank access manway lids

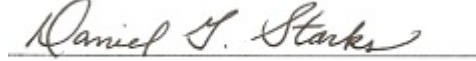
