Replacing existing poly tank sumps with new Bravo fiberglass single wall tank containment sumps. Installing new ball valves and flex connectors in tank sumps.

Amendment Reason: We will be removing/disabling all the ball floats and will be using the overfill drop tubes for overfill protection.

NOTE: If the balls are being knocked out then the overfill drop tubes must be set at 90%
