Changing form of overfill prevention from ball float valve to overfill drop tube valve. Installing OPW 61SOP valves in tank ID #1-2-3 and OPW 71SO in tank ID #4. Ball float valves will be removed or disabled.

NOTE: If ball floats are simply disabled the drop tubes must be set to 90% shut off
