(5) <u>SPECIAL CONTINGENCIES</u>:

Installation of three spill containments and three overfill prevention valves on the diesel tanks to comply with State Regulations. Repairs prompted by NOV. We will attempt to remove ball floats- if this does not work they will be disabled.

NOTE: If ball is simply knocked out, then drop tubes must be set at 90% shut off
