All tanks will have the ball floats disabled. All tanks will still utilize the existing overfill prevention drop tubes. The Diesel and Premium tanks will have the failed spill containers replaced.

NOTE: Drop tubes must be set at 90% shut off

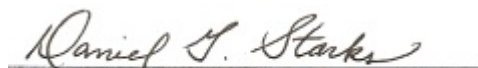
