**(5) SPECIAL CONTINGENCIES :**

Install new double wall ameron LCX pipe from tank 4 tank sump to closest two dispensers (1/2, 3/4). Perform pressurized line testing and hydrostatically test existing tank sump and UDC sumps. Convert tank 4 to diesel.

**NOTE: Contractor states that this is a new piping run, not a replacement. Site has existing sumps at both submersible and dispensers as well as existing sump sensors. Sensors must shut down the submersible pump upon detection of a leak per 175.640 a)**
