This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) SPECIAL CONTINGENCIES: Tank and piping to be removed, building has been demolished, found during construction activities. Tank #1 will be removed if found, unable to locate at this point, as discussed on 4/29 with Shelly B. Map attached showing the location of the 4,000 gallon tank.
