NOTE: In attached scope of work it states that the spill containment will be replaced, assuming under a like for like, to address violation on the N.O.V.

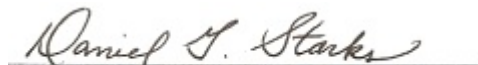
