- 2) Disconnect piping in the transition sump.
- 3) Install the new transition sump.
- 4) Re-install existing piping and new entry boots.
- 5) Perform sump test and nitrogen test on product lines.
- 6) Purge line and perform precision line test.
- 7) perform final inspection with OSFM.
