(5) **SPECIAL CONTINGENCIES** : We will be removing the ball float vent valves on all tanks per section D of the NOV (I forgot to add this to the original permit application). We will also be installing 71SO overfill prevention drop tubes as the form of overfill prevention in all tanks per section D of the NOV. The premium fill riser needs to be replaced due to severe internal corrosion and broken riser threads.
