THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.

This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

Removal of tank 1, 2, 3 from site but tank 2 & 3 is a comparent tank.

NOTE: All associated piping must be removed as well
