The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

(5) **SPECIAL CONTINGENCIES** : Interstate Pump & Tank will saw-cut and break-out concrete around islands. Expose pipe chase back a few feet. Remove all 3 dispensers to complete piping modifications and install new dispenser sumps. The existing dispensers will be re-installed with six new riser assemblies and impact valves
