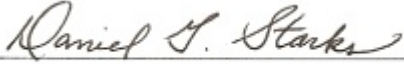
(5) **SPECIAL CONTINGENCIES** : Saw cut and break out area around existing RUL piping sump. Remove and replace cracked STP sump. After sump is installed and piping is reconnected, have third party testing of line tightness. Patch concrete to match existing grades
