Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(5) <u>SPECIAL CONTINGENCIES</u> :

We are planning to remove the existing single wall fiberglass piping From beneath the canopy area back to an existing transition sump. After the safe removal of the old fuel lines and appropriate soil sampling from below the dispensers and lines throughout the trench, the existing canopy will be taken down and removed. New Canopy system to be installed. We will be installing new APT 2" flexible piping and sumps for secondary containment. There will be a total of 3 dispenser sumps installed and roughly 260' of piping
