This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

- (5) SPECIAL CONTINGENCIES** : Remove, cut, clean, and dispose of one (1) 10,000 gallon heatint oil UST.
