- (a) *Number and size tanks being abandoned: (TK # 1) - 15,000*
- (b) *Product stored in each tank: (TK # 1) - Heating Oil*
- (c) *Location of tanks being abandoned: Tank & piping to be abandoned in place, unable to remove due to close proximity to the building.*
- (d) *Location of piping being abandoned: Tank & piping to be abandoned in place, unable to remove due to close proximity to the building.*

- (4) This permit is VOID if contamination is revealed during abandonment procedures or if tanks are not as indicated on your granted permit site plan. If contamination is revealed, this abandonment can continue only when the contaminated site section (2) of the certification on site condition has been submitted to our Office.
