Install (1) 9 pound anode in each, tank 3 STP sump, tank 4 STP sump, and tank 8 STP sump for good practice.

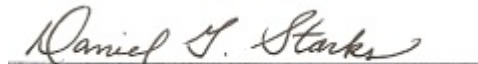
