The existing submerged pump has a bad 4" riser pipe. Remove the existing STP. Install a new STP sump in the same location (middle tank) and modify the existing single wall product piping as needed for the sump installlation. Install different submerged pump, Install new flex connector, ball valve and steel piping to connect the STP.

Amendment Reason: When I filled out the permit, I did not realize there were two RUL tanks. The Mid Grade tank is shown, so our work was actually done on the tank that is listed here as the Mid Grade tank and not the UL tank.
