Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

- (4) The owner must notify this Office when completion of tank removal has occurred, on the Notification for Underground Storage Tank Form. This form can be obtained at www.sfm.illinois.gov or by calling (217)785-1020. After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

#### (5) SPECIAL CONTINGENCIES:

Remove five (5) undergorund storage tanks (USTs). Utilize vacuum truck to pump out any residual product /liquid remaining in tanks. Excavate to expose top of tanks. Ground/bond tanks. Vent or inert tanks. Check LEL or O2, when <5%, excavate to expose tanks. Lift tanks with crane or back-hoe. Place tanks on poly. Re-check LEL/O2, when <5% cut opening(s) in tanks using non-sparking tools. Clean tanks/drum tank scrapings. Place tanks on trailer and haul to scrap yard.

NOTE: All associated piping must be removed as well
