Installing new swfrp STP sumps on all existing tanks. Installing Nupi Smartflex DW piping from new STP sumps where a transition sump will be installed to facilitate the connecting of new Nupi piping to the existing dwfrp piping.

Replaced piping exceeds 20 feet or 50% of the total pipe run.
