(5) SPECIAL CONTINGENCIES :

Upgrade existing fuel system. Removing the island, tank top equipment including overspill manhole, product piping, vent piping and steel risers.

Installing new tank top equipment including fiberglass tank sumps, new overspill manholes, overfill valves, new double wall fiberglass pipe to new island. the new island will have a dispenser pan and dual product dispenser. Island will have bollards for crash protection.

Installing a new Veeder Root TLS 4i to monitor tanks and perform tank tests.

At the island, under the dispensers will be a shear valve with check valve. The dispenser is a suction pump.

Replaced piping exceeds 20 feet or 50% of the total pipe run.

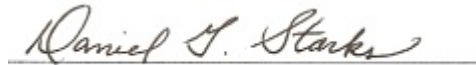
