This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.
- (5) <u>SPECIAL CONTINGENCIES</u>: Removing exsisting dispensers, UDC's, islands, spill containers, STP pumps, tank sumps and associated fuel piping/electrical and replacing with new.
