Permit for REMOVAL of Underground Storage Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

(4) After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

(5) SPECIAL CONTINGENCIES : Transition sump was found to have a crack in the sidewall after excavation and will not be able to be used. The sump will be removed and the remaining lines to the STP motor sumps. Line length to be removed totals less than 15 feet per line. We will now be running new fuel lines from the currently installed STP motor sumps to the new UDC's.
