This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

(5) SPECIAL CONTINGENCIES : The work will entail the excavation and removal of one approximately 275-gallon tank formerly containing gasoline and the associated piping located at 7801 W 47th St McCook, IL 60525
