- (5) SPECIAL CONTINGENCIES: We uncovered sections of the piping run depicted in green on the siteplan. We found a damaged area on the 3" outerwall pipe (piping is 3" over 2"). We plan to repair the damaged section with a repair coupling and re-install the clamshells that needed removed to find the leak. We will repair the 3" outerwall and test the secondary 3 inch outerwall pipe. No primary piping will be affected by the repairs. Any questions please let me know.
