## (5) <u>SPECIAL CONTINGENCIES</u>: REPLACE THE TANK 3 DIESEL SPILL BUCKET

- 1. Saw cut and demo around the off road diesel spill bucket, there will be an 18" manhole in the demo. Load and dispose of the concrete,
- 2. Remove and save the fill cap, adaptor and drop tube. (the drop tube is removeable)
- 3. Remove the spill bucket and replace with an OPW 1C-3112D double wall spill bucket.
- 4. Reinstall the drop tube, fill adaptor and cap.
- 5. Water test the spill bucket.
