- 1. All three (3) spills and both vapor manholes are all inches from each other. All these will be in the demo.
- 2. Furnish an ILOSFM upgrade permit,
- 3. Saw cut and demo, load and dispose of the concrete.
- 4. Remove and discard the fill caps, adaptors and spill buckets.
- 5. Furnish and install new spills, swivel fill adaptors and caps.
- 6. Water test the spill buckets
