The contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall submit a required job schedule for underground piping upgrade, leak detection, spill and overfill prevention of underground storage tank(s) to the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety.

(5) SPECIAL CONTINGENCIES : 1. Saw cut and demo around the premium spill bucket, there will be an 18" manhole in the demo. Load and dispose of the concrete.
2. Remove and dispose of the fill cap and adaptor, remove and save the drop tube.
3. Remove existing sw spill bucket, furnish and install a new dw spill bucket.
4. Reinstall existing drop tube, furnish and install a new swivel fill adaptor and flat cap.
5. Water test the spill bucket.

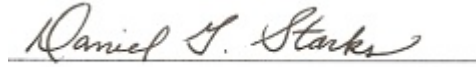
