- (a) Number and size of tanks being upgraded or repaired:* (TK # 10, 11, 12, 13) - 10,000 gallons, (TK # 14) - 8,000 gallons
- (b) Type of flex connector(s):* (TK # 10, 11, 12, 13, 14) - Existing steel flex connectors
- (c) Product stored in each tank:* (TK # 10, 11, 12, 13) - Gasoline, (TK # 14) - Diesel Fuel
- (d) Corrosion Protection being installed with flex connector(s):* (TK # 10, 11, 12, 13, 14) - (Installing) Sacrificial anodes cathodic protection at all submersible sumps and at any dispenser sumps that may be necessary. Anodes will be installed for any exposed metal piping and / or flex connectors.

- (4) The owner must notify this Office when completion of flex connector upgrade/repair has occurred, on the Notification for Underground Storage Tank Form and the licensed contractor must submit the required job schedule for flex connector to the OSFM prior to the work being performed.
