#### Permit for REMOVAL of Underground Storage Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

### (5) **SPECIAL CONTINGENCIES**:

We will be removing the old E85 Line and installing a new APT1.5xp Double wall Flexable pipe. Installing new AG Subpump, single wall containments, and sensors in all sumps. also installing a ne Gilbarco Encore 700 NAO dispenser.

NOTES: Only the piping can be removed under this permit, all other work will need to be done under a separate upgrade application. A blended fuel compatibility form must be submitted with the upgrade permit.
