Permit for REMOVAL of Underground Storage Tank(s) and Piping for Petroleum and Hazardous Substances.

Permission to remove underground storage tank(s) or piping is hereby granted. Such removal shall not commence until the contractor the permit was issued to or an employee of that contractor (this does not include a subcontractor) shall establish a date certain to perform the UST activity by contacting the Office of the State Fire Marshal, Division of Petroleum and Chemical Safety, at which time the UST activity shall be scheduled. **THIS PERMIT IS VALID FOR SIX MONTHS FROM THE APPROVAL DATE.**

- (4) The owner must notify this Office when completion of tank removal has occurred, on the Notification for Underground Storage Tank Form. This form can be obtained at www.sfm.illinois.gov or by calling (217)785-1020. After removal is completed, the owner/operator shall perform a site assessment by measuring for the presence of a release where contamination is most likely to be present at the UST site. This is in accordance with the Illinois Administrative Code 176.360 (a) regulations and 40 CFR Part 280.72 (a) Federal Register Requirement.

(5) **SPECIAL CONTINGENCIES**:

The orphaned USTs, which are neither owned or operated by IDOT, were encountered during the construction activities conducted within IDOT ROW on the SE quadrant of IL 128/US 40 in Altamont, IL, Contract 74752. Upon encountering the ophaned USTs construction activities were haulted and the site secured to prevent tampering. No visual/olfactory evidence of impact to the surrounding substrate was documented/noted. The necessary IDOT personnel were notified by Western via email. The IDOT Project RE was present when the orpahned USTs were encountered.

Removal activities will included:

- OFSM Removal Permit application submittal/approval/scheduling, JULIE utility pre-mark/notification. Once the Removal Permit application is approved and the removal activities scheduled Western will mobilize to the project site to uncover the top of the orphaned USTs. EnviroVac Waste services will pump/remove the liquid contents and transport to Illini Waste in Caseyville, IL. Under the supervision of the OFSM Inspector Western will uncover the orphaned USTs, monitor the tank atmosphere to ensure safe working conditions, and remove the USTs from the excavation area. Upon removal the USTs will be seceured, cut open via air driven tools, and cleaned for recylcling purposes while the UST atmosphere is continuously monitored to ensure safe working conditions. All content residuals/sludge will be containerized in 55-gal drums and transported to Illini Waste by EnviroVac Waste for disposal. Following removal activities Western, under the supervision of the OFSM Inspector, will conduct Site Assessment soil sampling, including the sidewalls and floor of the excavation, to document any impact to the surrounding substrate. Once the analytical results are received Western will submit the OFSM Site Assessment report documenting the site activities conducted to address the orphaned USTs. The UST excavation will be backfilled by the Contractor according to IDOT/project requirements.

Following UST removal activities IDOT/Contractor will resume the planned site activities which include storm sewer installation and intersection upgrades.
